Albert Jan van den Berg (Netherlands) is a partner in Hanotiau & van den Berg (Brussels, Belgium). He is a Professor of Law (arbitration chair) at Erasmus University, Rotterdam and a Visiting Professor at University of Miami School of Law and Tsinghua University in Beijing. Professor van den Berg acts as presiding and party-appointed arbitrator in numerous international commercial and investment arbitrations. He also is counsel in international commercial arbitrations. He is a member ICCA and General Editor of the ICCA Publications. Professor van den Berg was awarded “*Arbitration Lawyer of the Year Award*” by The International Who’s Who of Business Lawyers in 2006 and 2011 and the “*Best prepared/most responsive arbitrator*” in 2013 by Global Arbitration Review.
