With no ready market for private company shares, the protagonists have no choice but to fight. Do contractual remedies such as 'shoot outs' provide fair outcomes to these disputes? This session will consider common causes of disputes in private companies and in the boardroom

In particular, the committee seeks to explore the differences of approach between the common law and civil law traditions, and to encourage a dialogue between practitioners from these two systems.

Close links are maintained with various organisations such as the American Bar Association Litigation Section, the British Institute of International and Comparative Law and the Australian Corporate Lawyers Association.

The committee meets annually at the main IBA Conference and also has a specialist litigation conference generally held in May or June each year, together with regular seminars and events organised by the committee's local country chairs. The Annual IBA Conference also provides an occasion for the Young Litigators Forum to offer a forum for young lawyers to present papers and exchange ideas.

Committee members receive regular copies of the committee's newsletter which provides details of the committee's current activities plus recent developments in the law worldwide. Members also receive the biannual journal of the IBA's Dispute Resolution Section, *Dispute Resolution International*. Full details of the committee's Executive Committee and its regional and country chairs are published in the newsletter, and are available on this website. ### The Corporate Counsel Forum overview

The mission of the Corporate Counsel Forum is to be the pre-eminent forum within the IBA for discussion, education and comment by, for and among corporate counsel, respecting the proper role and expectations of the professional acting for a corporation.

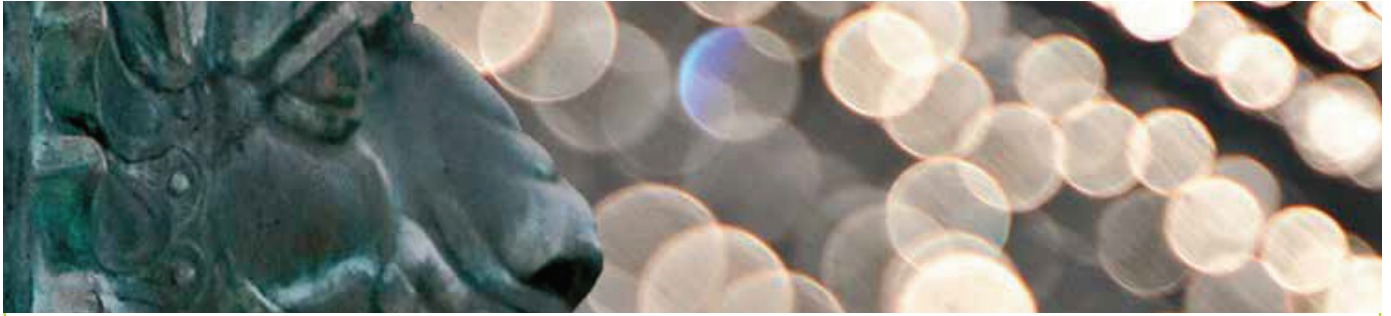
